COUNT 1: MURDER IN THE SECOND DEGREE - ORS 163.115: That the said defendant, on or about June 9, 2025, in Deschutes County, Oregon, did unlawfully and intentionally cause the death of Tracy Lynn Berry, another human being.

COUNT 2: UNLAWFUL USE OF A WEAPON - ORS 166.220(1)(A): That the said defendant, on or about June 9, 2025, in Deschutes County, Oregon, did intentionally and did attempt to use, or did carry or possess with intent to use, unlawfully against Tracy Lynn Berry, a knife, a dangerous or deadly weapon.
