COUNT 2: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a red, white, and black banded snake, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

COUNT 3: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown lizard in a gray metal and glass cage, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

COUNT 4: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown snake in a glass cage labeled "Southern Pacific Rattlesnake," an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

<u>COUNT 5: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330</u>: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a black snake in a wood and glass cage, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals

COUNT 6: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown, spotted snake in a cage labeled "Great Basin Rattlesnake," an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

COUNT 7: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: light yellow lizard in a glass cage labeled "Bearded Dragon," an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals

COUNT 8: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown lizard in a glass cage with a tortoise shell, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

<u>COUNT 10: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330</u>: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: brown, spotted snake in a chest freezer, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

COUNT 11: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown small snake inside a ziplock bag , an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals

COUNT 12: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown, spotted snake in a white plastic bag , an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

COUNT 18: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a yellow and brown tortoise in a wood cage, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.

COUNT 25: ANIMAL NEGLECT IN THE FIRST DEGREE - ORS 167.330: That the said defendant, on or between July 1, 2023 and October 6, 2024, in Deschutes County, Oregon, did unlawfully and with criminal negligence fail to provide minimum care for an animal, to-wit: a brown snake under a faux rock in a white cage, an animal in defendant's custody or control, such failure resulting in the death of the animal, and the offense was part of a criminal episode involving more than 40 animals.
